Important Notice about upcoming changes to Funds Availability Amounts

Effective July 1, 2025, funds available to members the next business day after a check deposit will increase from \$225 to \$275. In addition, the threshold for exception holds for large deposits and the amounts available for withdrawal for certain deposits or to new member accounts will increase from \$5,525 to \$6,025.
